



## Mr. Dan G. Askins Sr.

August 5, 1922 - July 30, 2012

Funeral services for Dan Gerald Askins, Sr., 89, will be held at 11:00 a.m. Saturday, August 4, 2012 at St. Luke United Methodist Church. The Rev.
