July 14, 1946 - September 3, 2024

Nancy Sheridan Cook Law, 78, of Columbia, SC, passed away on September 3, 2024. She was born July 14, 1946, in Columbia, SC, the daughter of the late Frances Edith Sheridan and William Roy Cook, Sr. She lived in Charleston, SC as a young child. In 1956, the family moved to Hartsville, SC.

Nancy graduated from Hartsville High School in 1964 and from Columbia College in 1968. She married her former husband, the late John Latta Law (Ret. Lt. Colonel), and lived in Spartanburg, SC, before moving to Columbia, SC, in 1980.
